MEMORANDUM

In continuation of the earlier memorandum issued vide no. 6 (6)-RD/TRLM/ 2015/11622-31 dated 17/3/2018, following points according to the financial plan of Cluster Level Federations (CLFs) to be considered:

1. If the SHG is under the membership of CLF, Community Investment Fund (CIF) will be disbursed to the SHGs through CLF.
2. Idle fund of Village Organisations (VOs), in the form of CIF (only principal) is to be transferred to CLF Bank account immediately after the formation of CLF.
3. In case of outstanding loan with SHGs, on repayment of loan by SHG to VO the principal amount to be transferred to CLF as per the plan made by VO & CLF.

MEMORANDUM

Cluster Level Federation (CLF) has been formed in 9 (nine) clusters of Resource Blocks of TRLM. Accordingly Bank account has already been opened and first phase meeting for selection of Office Bearer (OB) has also been completed. According to the proposed financial plan of CLF, the following actions need to be taken immediately:

1. Where the SHG is under the membership of the CLF, CIF will be disbursed to the SHGs through the CLF.
2. Idle fund of VOs, if any, in the form of CIF is to be transferred to CLF Bank account, keeping aside the amount of CIF supposed to be disbursed to SHGs during the month of March 2018.
3. Amount of CIF instalments to be repaid by the SHGs w.e.f. April 2018 should be transferred to the CLF Bank account as and when received by the VOs under CLF.
4. Interest of CIF scheduled to be repaid by the SHGs up to March, 2018 need not be transferred to CLF Bank account. It would be retained by the VOs. Interest of CIF should be transferred to CLF Bank account from April 2018 onwards.
