An earnest money amounting to ₹ 20,000/- (Rupees Twenty Thousand) only will have to be deposited in the shape of D-Call from any Nationalized bank/Tripura Garmin Bank/Tripura State Co-operative bank in favor of the "Holding Account DMMU Khowai TRLM" with the sealed quotation. The said earnest money will be converted to security money for the successful bidder. For others the earnest money would be refunded after finalization of the work order. Tender should be dropped in the tender box, which is kept in the chamber of the Addl. District Mission Manager (ADM & Collector), Khowai District.
- 2. The TRLM SHG, Vo, CLF under of this District, will get the first preference.
- 3. For the TRLM SHG/VO/CLF, NRLM registration, FSSAI certificate, Pan Card, and GST Registration are required.
- 4. The bidders should submit a Trade license, GST Registration certificate, and fssai certificate, Pan card must be submitted.
- 5. Any overwriting/penned through, etc., in any figure/name in the quotation will be disqualified on the part of the bidders and the quotation shall be liable to be rejected unless it is noted separately with signatures and seal (if any).
- 6. The Tenderers are requested to provide their details, address along with PIN code, Phone, Mobile No, etc, for easier communication.
- 7. Any overwriting or white colour used in the tender form is treated as a cancellation without any reason.
- 8. Any incomplete tender form is treated as cancelled without any reason.
- 9. All documents submitted with the tender are self-attested by the concerned bidders without being signed by them; it's treated as cancelled.

- 12. Quality and Quantity aspects of all cooked food must be strictly adhered to. If any genuine complaint is received for quality/quantity, etc., from any concerns, the undersigned may impose a penalty of ₹ 20,000/- (Rupees Twenty Thousand) only per case on the concerned bidder.
- 13. Cooked food items must be supplied as per the choice of the undersigned and by of a changing menu (within the accepted price) basis.
- 14. All the raw materials should be fresh and without pests, and cooked food must be fresh, hygienic, hot palatable within the rate quoted by the party.
- 15. Improved diets in a month must be of good quality and, as per the choice of the undersigned, for which no extra payment to be made.
- 16. The rate must be quoted inclusive of all charges & taxes allied to that. The service provider has to comply with all the rules and regulations of the undersigned and the Government as applicable for similar types of work.
- 17. The rate should be quoted both in digits and words.
- 18. Applicable taxes shall be recovered from the bill.
- 19. Quality and regular supply are the essence of supply, and the undersigned will cancel the order unilaterally if the above are not complied with and a violation of any terms and conditions occurs. Penalty of ₹ 20,000/- (Rupees Twenty Thousand) only per case to be levied on the bidder.
- 20. The contract is valid from the date of signing of formal acceptance by the undersigned.

- 23. If the contractor/ Supplier fails to comply with the relevant provisions of the abovementioned Acts, then the Institute Administration has every right to withhold the bills or even terminate the work order.
- 24. Utensils for cooking, servicing, preservation etc., have to be arranged in sufficient numbers by the contractor/ Supplier at his own cost.
- 25. The tenderer must take all the local conditions into consideration before filling up the bid documents.
- 26. The undersigned reserves the right to terminate the contract within the period of agreement by giving notice of 15 days (Fifteen days) without citing any reason
