Terms of Reference (ToR)

1. Introduction:

This **Expression of Interest (EOI)** is issued by Tripura Rural Livelihood Mission (TRLM) for the purpose of procuring machinery and equipment required for setting up an **Areca Nut Leaf Plate Making Unit**. The aim is to establish a state- of-the-art, sustainable production facility that will manufacture biodegradable, eco- friendly disposable plates made from Areca Nut leaves. These plates are considered an environmentally responsible alternative to plastic and are becoming increasingly popular in various industries, particularly in the food service and catering sectors.

The successful establishment of this unit is a part of our commitment to promoting sustainable manufacturing practices and reducing environmental impact. The procured machinery will help increase production capacity, maintain product quality, and cater to the growing demand for natural, biodegradable plates.

2. Background:

Areca Nut Leaf Plates are a traditional and highly sustainable alternative to plastic plates. These plates are made from the leaves of the Areca Nut palm tree, which is widely grown in tropical regions. The leaves are naturally strong, durable, and biodegradable, making them an excellent choice for a variety of applications. In addition to being eco-friendly, Areca Nut Leaf plates are also known for their elegant aesthetic and sturdiness, making them perfect for serving food during festivals, weddings, and various events.

As global awareness of environmental issues increases, the demand for biodegradable and sustainable products has surged, creating an opportunity for organizations to manufacture these eco-friendly plates on a larger scale. TRLM intends to tap into this market by procuring advanced machinery capable of converting Areca Nut leaves into quality plates efficiently. 3. Scope of Work:

The selected vendor will be responsible for providing, installing, commissioning and maintenance of machinery and equipment necessary to set up a fully functional Areca Nut Leaf Plate Making Unit. The machinery must be capable of processing raw Areca Nut leaves into finished plates that meet the quality standards specified by the organization.

The scope of work includes, but is not limited to:

- A. **Pre-processing Machinery**: This includes machinery designed for proper, cleaning, and sorting of Areca Nut leaves to prepare them for further processing. The machine should ensure that the leaves are thoroughly cleaned and free from contamination.

- D. **Packing Machines**: For packaging the finished plates into user-friendly bundles or individual packs. The packaging machines should be to enhance the packaging of products in a desired quality and presentation.
- E. **Maintenance and Operational Training**: The selected vendor will provide thorough training on the operation and maintenance of all machinery to ensure smooth and uninterrupted production. The training should include both operational and safety instructions.
- F. **Spare Parts and After-Sales Support**: The vendor must ensure the availability of spare parts of the machinery and provide a post-installation support agreement for a minimum of 3 years. This will include regular servicing, troubleshooting, and technical assistance.
